### MEETING CALLED TO ORDER

Chair Val Ogden called the meeting to order at 9:03 a.m. Introductions were made and a quorum was determined.

Chair Ogden asked for a moment of silence in remembrance of U.S. Forest Service officer, Kristine Fairbanks, who was killed September 20<sup>th</sup>.

### CONSENT CALENDAR

(See notebook item #2)

Reviewed Resolution #2008-031 Consent Calendar approving:

- a) Approval of RCFB Minutes – June 19 and 20, 2008
- b) Time Extension, RCO #04-1134D Washington State Parks, Willapa Hills Trail Bridge Decking

Bill Chapman **MOVED** to adopt Resolution #2008-031, approving the items on the Consent Calendar. Jeff Parsons **SECONDED**.

Resolution #2008-031 **APPROVED** as presented.

### MANAGEMENT REPORTS

Director Kaleen Cottingham presented this agenda item. (See notebook item #3 for detailed report.)

Kaleen highlighted several items that staff has worked on since the last meeting:

- Technical review and grant evaluations – Kaleen acknowledged and expressed appreciation for the many outstanding volunteers who helped with the application review and evaluation process.
- Budget preparation for the next biennium (2009-2011) – Kaleen reported that the budget was submitted to the Office of Financial Management (OFM) and the Governor on time. Starting with the next meeting, staff will be adding an additional chart that will show all of the appropriations by biennium and the rate at which they are being used.
- Board feedback – Staff will email an assessment survey to Board members to evaluate each meeting.
- Sustainability of Board meetings – Kaleen noted that staff is proposing several options for reducing costs and improving the sustainability of meetings, such as having Board members use an electronic version of meeting materials instead of a paper copy in plastic binders
- Staff changes – Kaleen introduced new staff members: Scott Robinson, section manager for the new Conservation and Grant Services Section; Tauren Ibarra, administrative assistant in the Recreation Section; Gary Cooper, grant manager in the Recreation Section. Laura Moxham, a new grant manager in the Recreation Section, could not attend the meeting.
- State Comprehensive Outdoor Recreation Plan (SCORP) – The National Park Service (NPS) has accepted the new SCORP, which was recognized at a national level as a model plan for other states. The NPS awarded a grant to RCO for testing the Level of Service concept, but the project is on hold due to the current budget situation.

### *Berk Report Update*

Rachael Langen gave an overview of the most recent changes from the recommendations provided by Berk and Associates to reduce reappropriations and project delays.

- Organizational Structure
  - To reduce the supervisory span for the section manager, the Recreation and Conservation Section has been divided into two sections. Marguerite Austin manages the Recreation Section and Scott Robinson manages the Conservation and Grant Services Section.
    - The Recreation Section has been further split into two subsections, thereby reducing the number of programs for each outdoor grant manager.
    - The Conservation and Grant Services Section includes three grant managers in addition to a conservation specialist, a cultural resources specialist, a planner, and an accessibility specialist who assist all outdoor grant managers.
  - A new policy unit was formed to provide policy analysis, moving these tasks away from grant managers
  - Two additional outdoor grant managers for the Recreation Section were hired.
- Business Practices/Notification Improvements
  - Automatic reminders now are sent to project sponsors 90 days before an agreement funding end date and 30 days before a critical milestone is due.
- Business Practices/Process Improvements
  - Strategica, Inc. was hired to map business processes for typical grant management activities. They also will be gathering feedback from stakeholders about RCO's grant processes. Mapping teams will work with the consultant to

look for ways to streamline and improve processes, as well as a consistent way of doing business among the grant management sections.

## **2009 MEETING SCHEDULE**

Rebecca Connolly presented this agenda item. (See notebook item #4 for details.)

Staff proposed that the Board meet four times in 2009 as follows:

- March 26-27, 2009 – Olympia
- July 9-10, 2009 – Bremerton
- September 21-22, 2009 – Olympia
- November 5-6, 2009 – Olympia

To reduce travel expenses, staff recommended that only one of the Board meetings be held outside of Olympia.

Dave Brittell **MOVED** to adopted Resolution #2008-032. Jeff Parsons **SECONDED**.

Rex Derr thanked staff for working around the State Parks Commission's schedule.

Bill Chapman noted that he would like to keep the option open for an additional travel meeting in 2009, possibly to Walla Walla.

Resolution #2008-032 **APPROVED** as presented.

## **PERFORMANCE REVIEW PROCESS FOR RCO DIRECTOR**

Rebecca Connolly presented this agenda item. (See notebook item #5 for details.)

Rebecca outlined the proposed process for Kaleen's annual evaluation as director of RCO.

1. Establish a subcommittee of the Board to work with the board liaison and the RCO's human resources manager to set criteria and solicit feedback from board members, chairs of other RCO-supported boards and councils, and key stakeholders about the performance of the director.
2. In executive session of the entire Board, discuss the results of the subcommittee's gathered information and reach a conclusion on the director's performance for the preceding year.
3. In executive session, present the Board's findings to the director with an opportunity for response.
4. The Chair will then verbally discuss the results of the performance evaluation with our designated liaison in the Governor's office.

Bill Chapman **MOVED** to adopt the review process. Craig Partridge **SECONDED** the motion. The motion was **APPROVED**.

Bill Chapman and Karen Daubert both agreed to serve on the subcommittee.

There was discussion on the process for collecting feedback regarding the director. Rebecca will work with Devi Watson, RCO's human resources manager, to begin compiling data and feedback for the subcommittee to review.

Chair Ogden said that she would like to begin working with the subcommittee to review the data by the second week of October and complete the evaluation by the November 2008 board meeting.

## **WASHINGTON WILDLIFE AND RECREATION PROGRAM (WWRP) OVERVIEW AND FRAMEWORK**

Jim Fox presented this agenda item. (See notebook item #6 for details.)

Jim gave an overview of how the funding is distributed across WWRP categories by statutory formula.

There was some discussion as to the reason for the \$40-\$50 million requirements for allocation of funds. Jim explained that this was designed by the Washington Wildlife and Recreation Coalition (WWRC) so as not to impact the two original accounts, Habitat Conservation and Outdoor Recreation accounts, if the appropriation from the Legislature were low. If the Legislature appropriated less than \$40 million, the Riparian Protection and Farmlands Preservation accounts would get nothing, but if the appropriation were \$40-\$50 million, funds would be given to the newer accounts. If the appropriation were over \$50 million the funds would be more evenly distributed among the four accounts.

Jim provided a handout of each WWRP category showing which projects would be funded if we receive the requested \$100 million.

Steven Drew said he would appreciate having a list showing which projects would be funded if we receive \$49 million or \$60 million. Jim noted that staff will provide these and any other funding levels requested by the Board.

Jim also reviewed the WWRP policies adopted by the Board in the past year and the grant process timeline. He explained that the Board's role at this meeting would be to approve the ranked lists.

## **WWRP – RIPARIAN PROTECTION AND FARMLAND PRESERVATION**

Scott Robinson presented this agenda item. (See notebook items #7a and #7b for details.)

### *Riparian Protection Account*

Scott provided details about this grant category. Riparian Protection Account projects provide water-related habitat for fish and wildlife. These habitats include estuaries, lakes, rivers, streams, shorelines, tidelands, and wetlands. To be eligible for consideration in this account, a project must include acquisition of real property interest.

The Riparian Protection Account receives funding only if the Legislature allocates more than \$40 million for WWRP. If the appropriation is between \$40 and \$50 million, then 40 percent of any amount over \$40 million goes into the account (\$0 to \$4 million). If the funding for WWRP exceeds \$50 million, then the account receives \$4 million, plus 30 percent of the amount above \$50 million.

Thirty-two Riparian Protection Account projects requesting \$31.6 million were evaluated on July 30–August 1, 2008 in an open public meeting.

Kammie Bunes provided an overview of the top three ranked projects in this category:

1. #08-1627A Kiket Island Riparian Acquisition from State Parks requesting \$2,000,000
2. #08-1330A Harstine Island – Scott Acquisition from State Parks requesting \$2,550,250 – tied for 2<sup>nd</sup> place
3. #08-1241A Green River Acquisition from King County DNR & Parks requesting \$875,000 – tied for 2<sup>nd</sup> place

Public Comments:

There were no public comments.

Board Discussion:

Steven Drew asked what happens with the funding line when there are tied projects.

Jim Fox explained that in the case of a tie, if one of the projects is a later phase of a previously funded project it would receive preference. Otherwise, the amount would be prorated between the projects.

Steven Drew **MOVED** to adopt Resolution #2008-033. Dave Brittell **SECONDED**.

Jeff Parsons expressed concern about the lack of riparian awards going to Eastern Washington and whether the evaluation criteria makes these projects less competitive. He would like staff to see if there is a reason for the low amount, such as not receiving applications or projects not ranking high enough.

Resolution #2008-033 **APPROVED**.

#### *Farmland Preservation Account*

Scott provided details about this grant program. The primary focus of the Farmland Preservation category in WWRP is to acquire development rights on farmland in Washington and to ensure that the land remains available for agricultural practices.

Sixteen Farmland Preservation Account project proposals requesting about \$7 million were evaluated on August 11–12, 2008. Upon completion of the presentations, evaluation team members agreed that the two projects submitted by the City of Spokane were not ready to be considered for funding at this time. Their reasons included the lack of clear goals or strategy, significance, long-term viability, data used to determine property values, and unclear landowner willingness.

Scott provided an overview of the top ranked project in this category:

- #08-1804A Smith Farm from Skagit County requesting \$319,455

Public Comments:

There were no public comments.

Board Discussion:

There was discussion about whether the Board can be assured that their investment would be protected in the future from floods and development. Kaleen noted that it may be helpful to have project sponsors include information about other conservation easements and protection in the general vicinity.

Jim Fox noted that one of the evaluation questions asks if there are other factors that could negatively affect the farmability of the property.

Scott explained the unique situation which caused the evaluation team to recommend not including the two Spokane projects on the ranked list.

Bill Chapman **MOVED** to adopt Resolution #2008-034. Jeff Parsons **SECONDED**.

Bill noted that two years ago, the Board conducted a second grant round when the category was undersubscribed, and thought it might be appropriate again and wants to have that discussion so that we are taking a plan to the Legislature.

There was discussion about lack of readiness in many counties, lack of geographic dispersion, and how the RCO grant criteria address threatened lands. The Board would like to look at ways to consider these policy issues.

Resolution #2008-034 **APPROVED**.

## **WWRP HABITAT CONSERVATION ACCOUNT (HCA) - CRITICAL HABITAT AND STATE LANDS RESTORATION**

Scott Robinson presented this agenda item. (See notebook items #8a and #8b for details.)

### *Critical Habitat*

Scott provided details about this grant category. Critical Habitat category projects provide habitat for wildlife including game and non-game species. These habitats include freshwater, saltwater, forests, riparian zones, shrub-steppe, wetlands, and winter range. Acquisitions often protect habitat for both federal and state endangered, threatened, or sensitive species. The Critical Habitat category is eligible to receive 40 percent of the WWRP funds in the Habitat Conservation Account.

Sixteen Critical Habitat category projects requesting \$36.6 million were evaluated on July 29-30, 2008 in an open public meeting.

Leslie Ryan-Connelly provided an overview of the top two ranked projects in this category:

1. #08-1504A West Branch Little Spokane River Phase II from WDFW requesting \$6,472,252
2. #08-1505 Methow Watershed Phase 6 from WDFW requesting \$3,500,000

Public Comments:

There were no public comments.

Jeff Parsons **MOVED** to adopt Resolution #2008-035. Dave Brittell **SECONDED**.

Resolution #2008-035 **APPROVED**.

### *State Lands Restoration*

Scott provided details about this grant category. State Lands Restoration category projects allow for restoration and enhancement of habitats on existing state lands. These habitats may include salt or freshwater areas, forests, riparian zones, shrub-steppe, wetlands, and other ecosystems or habitats native to Washington State. Restoration brings the site back to its

original function through activities that can reasonably be expected to result in a site that is, to the degree possible, self-sustaining. Enhancement improves the ecological functionality of the site. The State Lands Restoration and Enhancement category is eligible to receive 10 percent of the WWRP funds in the Habitat Conservation Account.

Twenty-one projects were evaluated between July 31 and August 14 through a written evaluation process. These projects totaled approximately \$4.7 million dollars.

Leslie Ryan-Connelly provided an overview of the top two ranked projects in this category:

1. #08-1524R Sinlahekin Ecosystem Restoration Phase 1 from WDFW requesting \$778,632
2. #08-1535R South Sound Prairie and Grassland Bald Restoration from WDFW requesting \$270,380

Public Comments:

There were no public comments.

Dave Brittell **MOVED** to adopt Resolution #2008-036. Craig Partridge **SECONDED**.

Board Discussion:

The Board discussed land restoration and how factors such as climate change could affect whether land could be restored to its original state. There also was discussion about the role of fire suppression in changing areas.

Kaleen noted that the issue of climate change and the impact it might have on conversion requests is on the agency's policy development list.

Resolution #2008-036 **APPROVED**.

## **WWRP HCA – NATURAL AREAS AND URBAN WILDLIFE**

Scott Robinson presented this agenda item. (See notebook items #8c and #8d for details.)

### *Natural Areas*

Scott provided details about this grant category. Projects in the Natural Areas category protect high quality, representative native ecosystems, or unique plant or animal communities. Species protected on these habitats often are classified as endangered, threatened, or sensitive at the federal or state level. Rare geological features or features of scientific or educational value also are considered. The Natural Areas category of the Habitat Conservation Account is eligible to receive 30 percent of the WWRP funds in the account.

Eight Natural Areas category projects, requesting \$16.5 million, were evaluated on July 28, 2008, in an open public meeting.

Kim Sellers provided an overview of the top two ranked projects in this category:

1. #08-1180A Lacamas Prairie Natural Area 2008 from DNR requesting \$3,540,022
2. #08-1186A Washougal Oaks NAP/NRCA 2008 from DNR requesting \$1,709,977

Public Comment:

There were no public comments.

Board Discussion:

Karen Daubert asked what criteria were used to recommend the Admiralty Inlet Heritage Forest Acquisition project over the Bone River/Niawiakum River project since they both received the same score.

Marguerite Austin explained that there are criteria such as project phasing that could determine whether one project is given preference over the other. The Board would make that decision in July 2009 when the actual funding decision is determined.

Steven Drew noticed that there was an error in where the funding line was placed on Table 1. He also noticed that at a funding level of \$100 million, the Bone River project could be fully funded with the Admiralty Inlet project partially funded instead of both projects receiving partial funding.

Craig Partridge asked what the common practice is for funding tied projects and how projects are prorated.

Jim Fox explained that projects are prorated based on the amount requested. He gave the example that if one project requests \$1 million and the other \$2 million, the funding would be prorated one part to two parts. Also, if a project has a tied score and is a later phase of a previously funded project, it would be given preference over the other project. Jim Fox noted that according to policy, the list should show that under this funding scenario, the Bone River project would be fully funded and the Admiralty Inlet project would receive partial funding.

Karen Daubert **MOVED** to adopt Resolution #2008-037. Craig Partridge **SECONDED**.

**MOTION APPROVED.**

Steven Drew **MOVED TO AMEND** Table 1 to put the Bone River and Niawiakum River project above the Admiralty Inlet Heritage Forest project. Karen Daubert **SECONDED**.

Resolution #2008-037 **APPROVED AS AMENDED.**

### *Urban Wildlife*

Scott provided details about this grant category. Urban Wildlife Habitat category projects provide habitat for fish and wildlife. These habitats include forests, riparian zones, and wetlands, and may serve as a corridor for wildlife movement in existing populated areas. To be eligible for consideration in this category, a project must be:

- Within five miles of the urban growth boundary of a city/town with a population of at least 5,000; or
- Within five miles of an adopted urban growth area in a county that has a population density of at least 200 people per square mile.

The Urban Wildlife Habitat category is eligible to receive 20 percent of the WWRP funds in the Habitat Conservation Account.

Fifteen Urban Wildlife Habitat category projects requesting \$17.7 million were evaluated on July 31–August 1, 2008, in an open public meeting.

Kim Sellers provided an overview of the top two ranked projects in this category:

1. #08-1334A Antoine Peak Acquisition Phase 2 from Spokane County Parks and Recreation requesting \$1,674,450
2. #08-1182A Stavis NRCA/Kitsap Forest NAP 2008 from DNR requesting \$1,586,025

Public Comment:

John Bottelli, Parks Special Projects Manager for Spokane County, thanked the Board for consideration of their project for Antoine Peak. He is very encouraged by the ranking their project received. They are ready to begin and have earmarked and maintained a balance in their conservation futures account to be used for match. They are submitting a waiver of retroactivity, which will save taxpayers about \$200,000. John also thanked WDFW for their support.

Steven Drew **MOVED** to adopt Resolution #2008-038. Craig Partridge **SECONDED**.

Resolution #2008-038 **APPROVED**.

Karen Daubert noted that she is glad to see the number of applications submitted, especially from local agencies.

Dave noted that many of these projects have good links to ecoregional assessments and the Biodiversity Council.

## **WWRP ORA - LOCAL PARKS, STATE LANDS DEVELOPMENT, TRAILS, WATER ACCESS, STATE PARKS**

Marguerite Austin presented this agenda item. (See notebook items #9a-e for details.)

Marguerite gave an overview of the WWRP Outdoor Recreation Account (ORA) and the five categories – Local Parks, State Lands Development, Trails, Water Access and State Parks. She noted some of the policy changes since the last grant round, including grant limits, evaluation criteria, the application process, and the evaluation process.

### *Local Parks*

Darrell Jennings provided details about this grant category. The Local Parks category provides funds for both active and passive outdoor recreation facilities. Acquisition, development, and renovation of existing facilities are eligible. Facilities may include athletic fields, hard courts, picnic sites, playgrounds, outdoor swimming pools, and support amenities.

The Local Parks category is eligible to receive 30 percent of the WWRP funds in the Outdoor Recreation Account. Fifty percent of the funds allocated in this category must be used for acquisition costs. Meeting this statutory requirement may require skipping higher-ranked development projects in favor of acquisition projects.

Seventy-six Local Parks category projects requesting \$30.8 million were evaluated August 4-8, 2008, in open public meetings.

Adam Cole provided an overview of the top two ranked projects in this category:

1. #08-1669 Evergreen Park Expansion/Shoreline Restoration from the City of Bremerton requesting \$500,000
2. #08-1603D Outdoor Swimming Pool Renovation from the City of Prosser requesting \$500,000

Public Comment:

Kellie Brennan, City of Prosser, stated that she supports the Prosser Outdoor Swimming Pool Renovation project. She thanked the Board for consideration of their project and RCO staff for being so helpful.

Board Discussion:

Steven Drew asked about outreach to the Tribes and why there were no applications submitted. Staff responded that the outreach is the same but the Tribes may have had match issues. Kaleen added information about specific outreach to Tribal organizations designed to encourage participation in WWRP.

Steven Drew questioned the City of Bremerton's project and the reasons behind terminating their previous grant for this new project.

Kaleen explained that it was unlikely that the city would be able to finish their original project within the next two years. This approach makes the returned funds available immediately to an alternate project on that list.

Jeff Parsons **MOVED** to adopt Resolution #2008-039. Steven Drew **SECONDED**.

Resolution #2008-039 **APPROVED**.

*State Lands Development and Renovation*

Marguerite provided details about this grant category. The State Lands Development and Renovation category provides funds for projects that involve development and renovation of public access facilities on existing state recreation lands. Typical facilities include campsites, fishing piers, interpretive trails, non-motorized boating access, picnic sites, and wildlife viewing blinds. The State Lands Development and Renovation category is eligible to receive five percent of the WWRP funds in the Outdoor Recreation Account.

Thirteen State Lands Development and Renovation category projects requesting \$3.5 million were evaluated July 28-August 12, 2008, through a written evaluation process.

Darrell Jennings provided an overview of the top two ranked projects in this category:

1. #08-1165D Mt. Si NRCA Trail Bridges from DNR requesting \$170,000
2. #08-1052D Samish Overlook from DNR requesting \$325,000

Public Comment:  
No public comment.

Bill Chapman **MOVED** to adopt Resolution #2008-040. Steven Drew **SECONDED**.

Karen commented on the small differences in point values and that it is an indication of good projects.

Resolution #2008-040 **APPROVED**.

*Trails*

Marguerite provided details about this grant category. The Trails category provides funds for pedestrian, bicycle, equestrian, or cross-country ski trails. Trails must be for nonmotorized use and cannot be part of a street or roadway. If located along a roadway, the trail must be separated from the roadway by a physical barrier. Sponsors may use funds for facilities such as parking and rest, picnic, or viewing areas that are directly related to an existing or proposed public trail. The Trails category is eligible to receive 20 percent of the WWRP funds in the Outdoor Recreation Account.

Thirty-six Trails Category projects requesting \$29.5 million were evaluated August 13-15, 2008, in open public meetings.

Sarah Thirtyacre provided an overview of the top two ranked projects in this category:

1. #08-1075D Spruce Railroad Trail Tunnel Restoration from Clallam County Public Works Department requesting \$999,000
2. #08-1332D Centennial Trail Realignment at Gateway Park from Spokane County Parks and Recreation requesting \$197,974

Public Comment:

No public comment

Board Discussion:

There was discussion about what the trails are for – hiking versus urban or regional. Staff explained that the typical trails in this category are urban or regional trails rather than backcountry hiking trails. The priority for urban regional trails is primarily determined by the evaluation criteria..

Steven Drew asked about the lack of DNR trails and the need for trail maintenance.

Marguerite noted that those trails don't typically score well in this category and are better aligned with the National Recreational Trails Program (NRTP) and the Nonhighway and Off-road Vehicle Activities (NOVA) program. In addition maintenance of existing trails is ineligible for WWRP funding.

Bill Chapman **MOVED** to adopt Resolution #2008-041. Rex Derr **SECONDED**.

Resolution #2008-041 **APPROVED**.

#### *Water Access*

Marguerite provided details about this grant category. The Water Access category funds projects that provide physical access to shorelines for non-motorized water related recreation activities. These include boating, fishing, swimming, and beach access. Acquisition and development include land and facilities that support water dependent recreation such as fishing piers and platforms, small boat access docks and launches, swim beaches, and water trails for canoes and kayaks.

The Water Access category is eligible to receive 15 percent of the WWRP funds in the Outdoor Recreation Account. Seventy-five percent of the funds allocated in this category must be used for acquisition costs. Meeting this statutory requirement may require skipping higher-ranked development projects in favor of acquisition projects.

Twenty-eight Water Access category projects requesting \$15.7 million were evaluated August 5-6 in open public meetings.

Myra Barker provided an overview of the top two ranked projects in this category:

1. #08-1096A Wapato Park Miranda Property Acquisition from Tacoma MPD requesting \$231,663
2. #08-1210D Chambers Creek North Dock and Pedestrian Overpass from Pierce County Public Works requesting \$750,000

Public Comments:  
No public comments.

Steven Drew **MOVED** to adopt Resolution #2008-042. Dave Brittell **SECONDED**.

Resolution #2008-042 **APPROVED**.

### *State Parks*

Marguerite provided details about this grant category. The State Parks category provides funds for acquiring and developing active and passive outdoor recreation facilities. Facilities may include campgrounds, fishing sites, picnic areas, swim beaches, trails, and support amenities including administrative and maintenance structures.

The State Parks category is eligible to receive 30 percent of the funds in the WWRP Outdoor Recreation Account. Fifty percent of the funds allocated in this category must be used for acquisition. Meeting this statutory requirement may require skipping higher-ranked development projects in favor of acquisition projects.

In November 2007 the Board adopted a revised evaluation process that delegated to the State Parks and Recreation Commission the evaluation and ranking of State Parks category projects. Eleven projects requesting \$22.2 million were evaluated on June 25, 2008, in an open public meeting. The evaluation team, comprised of State Parks staff, scored and ranked projects using criteria developed by State Parks and adopted by the Board. The results are shown in Table 1. In August 2008, the State Parks Commission adopted an alternate ranking (Table 2) and requests review and approval of this priority list since final approval of the list resides with the Board.

Gary Cooper provided an overview of the top six projects in this category, as prioritized by the Commission:

1. #08-1266D Pearrygin Lake Expansion – Phase 1 Development requesting \$1,000,000
2. #08-1884A Pearrygin Lake – Hill//Golf Course Acquisition requesting \$2,000,000
3. #08-1822A Statewide Inholdings and Adjacent 2008 requesting \$750,000
4. #08-1329A Kiket Island Acquisition requesting \$2,500,000
5. #08-1363A Loomis Lake Acquisition requesting \$2,516,675
6. #08-1801A Cape Disappointment Seaview Dunes requesting \$2,000,000

Public Comment:  
No public comment.

Board Discussion:  
Some Board members expressed concern about how project rankings were changed by State Parks after projects were evaluated.

Larry Fairleigh, Assistant Director for State Parks, assured the Board that the projects that were moved down the list would be funded from other sources, pending approval of the State Parks capital budget.

The Board acknowledged the need to continue refining the State Parks evaluation process.

Bill Chapman **MOVED** to adopt Resolution #2008-43. Karen Daubert **SECONDED**.

Resolution #2008-043 **APPROVED**. Jeff Parsons recused himself from the vote.

## **LAND AND WATER CONSERVATION FUND (LWCF) FUNDING DECISION**

Marguerite presented this agenda item. (See notebook item #14 for details.)

Marguerite provided details about this grant program. The federal LWCF program provides matching grants to states to preserve and develop quality outdoor recreation resources. Rules governing the program are in the federal LWCF Grant-in-Aid Manual.

The RCO received thirteen LWCF projects to review for federal fiscal year 2009 funding consideration. The requests total more than \$3.6 million.

Myra Barker provided an overview of the top two ranked projects in this category:

1. #08-1249A Fallen Leaf Lake from the City of Camas requesting \$500,000
2. #08-1257D Lions Park Waterfront Enhancement from Bremerton Parks & Recreation Department requesting \$500,000

Public Comment:

No public comment.

Board Discussion:

There was discussion about federal funding allocation for 2009 and beyond.

Marguerite noted that the Camas project will be funded with remaining 2008 funds, leaving \$11,000 for the next ranked project. Staff is working to close out expiring projects, which may give more money to alternate projects on the list.

Jeff Parsons **MOVED** to adopt Resolution #2008-049. Dave Brittell **SECONDED**.

Resolution #2008-049 **APPROVED**.

## **BOATING INFRASTRUCTURE GRANTS (BIG) FUNDING DECISION**

Marguerite presented this agenda item. (See notebook item #15 for details.)

Marguerite provided details about this grant program. The U.S. Congress created the BIG program under the Transportation Equity Act. The program, managed by the U.S. Fish and Wildlife Service (USFWS), provides funds for developing and renovating boating facilities for recreational boats 26 feet and larger. Sponsors also may use funds to provide information and to enhance boater education. Facilities eligible for funding include transient moorage docks, breakwaters, and buoys.

The USFWS has established two "tiers" of grants.

- Tier 1 is for projects that request \$100,000 or less. Each year, Washington State may submit Tier 1 applications requesting up to \$100,000 on behalf of itself or an eligible sub-sponsor. Tier 1 applications are not guaranteed, but have a high probability of funding approval.
- Tier 2 is for projects that request \$100,001 or more. States may submit applications for any number of Tier 2 grants on behalf of itself or an eligible sub-sponsor. These projects are submitted for national competition with no assurances of success.

RCO staff recommends approval of the ranked list of Tier 1 projects shown in Table 1, funding for one Tier 1 project, and authorization to submit one Tier 2 project for the national competition. Staff also recommends delegation of authority to the director to submit these projects to the U.S. Fish and Wildlife Service for consideration and/or national competition.

Public Comment:  
No public comment.

Marguerite shared evaluator's concerns about the Shaw Island Public Access project (Tier 2) with regard to public access. Better assurance is needed that the facility will be open and available for 20 years. One-third of the evaluators said there was not enough information provided by the applicant on this project.

Craig voiced concerns about the transparency of the evaluation for the Tier 2 Shaw Island project. He would like reassurance that the questions and criteria were straightforward.

Marguerite explained how the advisory committee asked for more information from the applicant concerning public access and costs. The sponsor is revising its application for full committee review. The deadline for submittal to the USFWS is October 31.

Karen Daubert **MOVED** to adopt Resolution #2008-050. Bill Chapman **SECONDED**.

Resolution #2008-050 **APPROVED**.

The meeting was reconvened at 9:04 a.m. by Chair Val Ogden.

### **BOARD REQUEST LEGISLATION**

Heath Packard presented this agenda item. (See notebook item #10 for details.)

#### *Mitigation Banking*

Heath gave an overview of the process and the changes proposed regarding mitigation banking projects. Staff recommended that the Board approve request legislation to remove mitigation banking project eligibility for grants in the Urban Wildlife Habitat, Critical Habitat, and Riparian Protection categories of WWRP.

Heath reported that staff has conducted stakeholder outreach regarding this proposal and all comments received reflect supportive or neutral positions on this proposal. Heath also noted that this will not affect the two mitigation banking projects that have previously been funded.

Staff further recommended that the Board consider recognizing the importance of mitigation banking and direct staff to continue to support Washington's efforts to improve the current mitigation banking approaches.

Jeff Parsons **MOVED** to adopt Resolution #2008-044. Karen Daubert **SECONDED**.

Craig Partridge said that he realizes that mitigation banking is an awkward fit for WWRP but supports the concept in general.

Bill Chapman noted that he would like the wording in the resolution to more strongly support mitigation banks.

Jeff Parsons said he would be comfortable with a statement that says that the Board is not commenting one way or another on the utility of mitigation banking.

Chair Ogden asked if the Board would rather table the adoption of Resolution 2008-044 until staff has a chance to revise the language.

Craig Partridge **MOVED** to amend the resolution by adding “without commenting generally on the value that mitigation banking might provide to other programs,” after the third WHEREAS.

Bill Chapman **SECONDED**.

Resolution #2008-044 was **APPROVED AS AMENDED**.

### *Population Proximity*

At its June 2008 meeting, the Board noted that it would like to preserve the intent of this law—placing parks near people – while updating the statute to reflect modern planning approaches and recreation needs.

Heath reviewed the four options, drafted by staff, for Board consideration.

1. Original proposal submitted for public and stakeholder comment
2. Modified original – focused on urban “parks,” based on stakeholder comments
3. “Urban areas” definition change only
4. Board policy changes only

Staff recommended that the Board approve Option 2, which modernizes the parks population proximity statute and related policies, and addresses the issues raised by some stakeholders. Heath presented a draft bill to revise the statute that requires the Board to give funding preference to park projects in or near urban areas.

### Board Discussion:

Several Board members expressed concern with how the recommendations would affect specific project categories and the current policies. There was considerable discussion about what should be in statute versus policy. There was also concern about possible ambiguity and how that would be perceived by stakeholders.

Heath pointed out that if staff and the Board were to go through every category and project type and make determinations ahead of time, the bill could be too lengthy and include too much policy detail in statute.

Bill Chapman asked if there might be a way to narrow the possible programs to which the policy statement may apply.

Jim Fox noted that not only were there 14 categories, but also many project types to consider, which would be very difficult to spell out in legislation. He believes that the Legislature may be more likely to favorably consider a simple legislation request and give the Board flexibility to implement it.

Karen Daubert noted that she would rather not rush into a decision but instead make sure there is Board consensus and revisit this issue next year.

Jeff Parsons said that he would like to wait and be sure that the legislative intent is absolutely clear before moving forward. He is concerned about the urban versus rural issue, the affordable housing situation, and other factors that add to the complexity of this decision.

Chair Ogden noted that the deadline for submitting legislation this year is September 29.

Jeff Parsons made a **MOTION** to form a subcommittee to study the issues regarding population proximity. Bill Chapman **SECONDED** the motion.

Craig Partridge commented that since there is confusion about the language and intent in the draft recommendation, he supports taking a step back to study this more thoroughly.

The motion was **APPROVED**.

Chair Ogden asked for volunteers for the subcommittee. Bill, Karen, Craig, Steven, and State Parks all offered to serve or were recommended for participation.

*Staff Note: Following the meeting, Heath worked with Board members to clearly identify the subcommittee membership and ensure that it is less than a quorum. Members of the subcommittee include the following: Karen Daubert, Bill Chapman, Larry Fairleigh, and Steven Drew.*

## **ANNOUNCEMENT FROM CHAIR OGDEN**

Chair Val Ogden read a letter that she wrote to Governor Gregoire announcing her decision not to seek another 2-year appointment as Chair of the RCFB.

The Chair reflected on some of the changes that occurred during her tenure: the WWRP budget increased from \$45 million to \$100 million; the agency and board changed their names; there is a new agency director; and the Legislature gave the Board several new grant programs.

Chair Ogden expressed her thanks and appreciation to the Board members and staff with whom she has had the pleasure of working for the past five years.

## **CONVERSION REQUEST: GRASS LAKE**

Kammie Bunes presented this agenda item. (See notebook item #11 for details.)

Kammie gave an overview of the request from the City of Olympia to convert two parcels totaling 2.59 acres within the Grass Lake Nature Park. The city has proposed to replace this property with 7.97 acres of generally superior habitat to remedy the conversions. If approved, 2.47 acres in the southwest corner of the Park would be converted to a neighborhood park and a sewer easement would be granted to an adjacent private landowner over 0.12 acres at northwest corner. The replacement exceeds habitat and market values and meets eligibility requirements.

### **Board Discussion:**

The Board discussed the easement for the proposed sewer line and whether the alternative to acquire an easement from other private property owners had been thoroughly explored. Dave Okerlund, representing the Olympia Parks, Art and Recreation, reported that in his conversation

with the landowner requesting the easement, he was told the other private landowners were not interested in selling an easement.

Jeff Parsons wondered why the two parts of the proposal were combined rather than allowing separate consideration of the two conversions. He said that he feels the park is consistent with the public benefit while the sewer easement is not.

Kammie explained that the conversion requests were submitted to her at the same time with a single replacement property and she felt it would be appropriate to do a cumulative impact approach. She stated it would be possible to divide the proposal into two separate conversions if that is what the Board decides to do. By separating them, the sewer easement would then fall under the threshold requiring Board action and instead be an administrative conversion, requiring only Director approval.

Steven Drew said that he thinks both parts of the conversion are appropriate for Board discussion, but would like to see them split into two as they are each of a different nature. He would like to see the sewer easement conversion option more thoroughly explored.

Steven Drew made a **MOTION** to split the proposed conversion between the 2.4 acres for the park and the .12 acres for the sewer easement. Jeff Parsons **SECONDED**.

The motion to split the conversion was **APPROVED**.

Kammie suggested modified language to the resolution that would address only the local park conversion.

Jeff Parsons **MOVED** to adopt Resolution #2008-047. Karen Daubert **SECONDED**.

Steven Drew **MOVED** to amend the resolution after the second WHEREAS by removing the easement language and changing the wording to read "...approval to convert 2.47 acres for a neighborhood park; and".

Jeff Parsons **SECONDED** the motion.

Resolution #2008-047 was **APPROVED AS AMENDED**.

Steven Drew asked that the sewer easement issue to come back to the Board for further discussion and decision. He restated that he is not convinced that other alternatives have been exhausted by the developer.

Bill Chapman noted that he believes that the RCO director has the authority to make a decision regarding the sewer easement issue.

Steven Drew noted that he respects the director's ability to make the decision. He also noted that conversion policy will increase in prevalence and importance for the Board as growth puts pressure on open space. The Board needs to become more engaged in the utility component of conversions.

Steven Drew made a **MOTION** to have ~~the~~this sewer easement conversion come back to the Board in November for a decision. Jeff Parsons **SECONDED**.

Bill Chapman, Karen Daubert, Craig Partridge, Dave Brittell, and Steve Hahn voted in opposition. The **MOTION FAILED**.

Karen noted that she appreciates Steve's points, and that it is important to consider the administrative versus board roles in conversions.

Steven Drew reiterated that he respects the director's ability to make the decision, but requested follow-up information from staff on the sewer easement conversion decision.

Jeff noted that conversions such as this one are important, but he is fine with the director having the authority to make the final decision. At a future meeting, he would like to have the Board discuss parameters for the director to consider when making this type of decision.

## **CONVERSION REQUEST: DFW LAND EXCHANGE**

Leslie Ryan-Connelly presented this agenda item. (See notebook item #12 for details.)

Leslie gave an overview of the proposal from the Washington Department of Fish and Wildlife (WDFW) to convert about 31,490 acres of wildlife area lands that it acquired with grants awarded by this Board. The conversion is part of a larger land exchange with the DNR. WDFW has identified parcels for conversion and replacement, is conducting appraisals, and expects the land exchange to occur by December 31, 2008. Staff is reviewing the conversion proposal and will present a complete analysis for final decision at the November Board meeting.

Board policy states that publicly owned lands cannot be used as replacement properties if they were previously managed for habitat conservation. As a result, some of the proposed replacement properties are not eligible. WDFW is asking the Board to waive this policy so that they can move forward on the proposed exchange. The waiver would apply only to the grants awarded with state funds, not the federally-funded grants through the LWCF, which is governed by federal regulations.

The waiver of the policy would make DNR trust land that WDFW previously leased eligible as replacement property for the state funded grants.

Leslie noted that staff recommends the Board approve the waiver collectively for all of the proposed DNR replacement properties that are part of the larger proposed land exchange.

### **Board Discussion:**

Board members questioned the future use of lands by DNR. Concern was expressed over the potential for net loss of either recreational or habitat land and which agency would have a greater ability to protect shrub steppe habitat land. Board members are especially concerned with forested areas.

Dave Brittell pointed out that the long-term protection of shrub steppe habitat is greater if it is in the hands of WDFW.

Steve Saunders, DNR Asset Management Manager, discussed future plans to develop a habitat conservation plan. He also noted the difficulty in managing lands for forest health, habitat, and recreation as they are now in a checkerboard pattern.

Jim Fox reminded the Board that, while it is appropriate for them to give some direction to WDFW and DNR, their decision right now is very focused on whether or not to waive the eligibility policy. There will be time for discussion on whether lands are adequate for replacement at the November meeting.

Karen Daubert **MOVED** to adopt Resolution #2008-046. Jeff Parsons **SECONDED**.

Resolution #2008-046 was **APPROVED** as presented.

Leslie clarified for the November meeting that the LWCF grants were awarded for recreation and therefore approximately 25,000 acres of converted property will be based on replacing that recreational utility. The WWRP grants were for habitat so approximately 7,000 acres will be based on habitat utility replacement.

Kaleen pointed out that DNR and WDFW will be able to move forward with the NEPA requirements now that the waiver was approved.

Dave thanked Kaleen and staff for being so helpful through this complex conversion process.

## **AQUATIC LANDS ENHANCEMENT ACCOUNT (ALEA) FUNDING DECISION**

Scott Robinson presented this agenda item. (See notebook item #13 for details.)

Scott provided details about this grant program. The ALEA grant program funds are used for the acquisition, restoration, or enhancement of aquatic lands for public purposes and for providing and improving public access to aquatic lands and associated waters. "Aquatic lands" means all tidelands, shorelands, harbor areas, and the beds of navigable waters.

Twenty-two ALEA projects, requesting more than \$9.1 million, were submitted for fiscal year 2010 funding consideration. The Board was being asked to approve the ranked list of projects, which would then be forwarded to the Governor for inclusion in the 2009-2011 Capital Budget.

Kammie Bunes provided an overview of the top two ranked projects in this category:

1. #08-1872D Lake Sammamish Sunset Beach Renovation 2 from State Parks requesting \$500,000
2. #08-1682C Lily Point Marine Reserve from Whatcom County Parks and Recreation requesting \$1,000,000

Bill Chapman **MOVED** to adopt Revised Resolution #2008-048. Karen Daubert **SECONDED**.

Craig Partridge talked about the importance of continuing to recognize the huge benefit this grant program derives from its revenue source, which is the public's ownership and ability to manage the lands. He noted that Washington State asserts one of the strongest degrees of ownership and management authority over public lands of any state in the country.

Revised Resolution #2008-048 **APPROVED** as presented.

**NOW, THEREFORE BE IT RESOLVED**, that, for WWRP projects to be converted as part of the proposed WDFW and WDNR land exchange, the Board hereby waives the policy in Manual 3, page 10, that prohibits acquisition of public lands that have been publicly managed for conservation purposes; and

**BE IT FURTHER RESOLVED**, that the waiver applies only to parcels that were temporarily managed for conservation and recreation purposes, and not to parcels that were acquired specifically for conservation or recreation purposes and protected in perpetuity.
